## AN ORDINANCE AMENDING ORDINANCE 22-01 DECLARING SPEED LIMITS ON STATE OF NORTH CAROLINA ROADWAYS IN THE TOWN OF DUCK

Ordinance No. 23-04

WHEREAS, pursuant to N.C Gen. Stat. §160A-174 a town may by ordinance define, prohibit, regulate or abate acts, omissions, or conditions, detrimental to the health, safety, or welfare of its citizens and the peace and dignity of the town; and

WHEREAS, pursuant to N.C. Gen. Stat. §20-141(f) a town may determine that a higher or lower maximum speed than those set forth §20-141(b) is reasonable or safe and, with concurrence of the Department of Transportation, may declare a safe and reasonable speed limit; and

WHEREAS, the Town Council of the Town of Duck adopted Ordinance #03-03 on May 7, 2003 and Ordinance Amendment 22-01 on January 19, 2022 establishing speed limits on state roads in the Town of Duck.

**NOW, THEREFORE, BE IT RESOLVED BY** the Town Council for the Town of Duck, North Carolina as follows:

PART I. The speed limits, which the Town Council declares as reasonable and safe, for the State roadways within the Town's jurisdiction are established as shown on the table that follows:
